These standards are encompassed in the MedTech Europe Code of Ethical Business Practice including the [Procedural Framework](#).

In this framework, the independent MedTech Europe Compliance Panel provides strategic direction and thought leadership in the field of business ethics to the MedTech industry. Accordingly, as provided in the Procedural Framework, the Panel, composed of three members, has the following tasks:

- Supervise the MedTech Europe [Conference Vetting System](#);
- Review consistency with the MedTech Europe Code of interpretations of national panels of nationally applicable codes of conduct, upon request of the MedTech Europe Code Committee;
- Provide guidance to Member Associations on the dispute resolution principles set out in the Procedural Framework;
- Interact, upon request of the MedTech Europe Secretariat, with relevant MedTech Europe groups (e.g. Code Committee) to further develop the Code and guidance documents;
- Render decisions directly on complaints or procedural matters, as a first and last instance in certain cases related to the MedTech Europe Code (see [Procedural Framework](#) for more information on the Panel's jurisdiction).

Profile:

MedTech Europe is looking for a candidate with solid experience to fulfil a strategic role within the European MedTech industry and as a member of the Compliance Panel.

To avoid any risk of conflict of interest, the candidate should not have any actual link or connection with a company or an Association, Member of MedTech Europe or be active within the MedTech industry. Though not a requirement—due to the need to avoid said conflicts of interest—current Panel members are no longer active professionals.

The candidate should have the following attributes:

- Legal background, preferably with experience in the Life Science industry;
- Working experience of at least 20 years, possibly with experience in trade association, including proven track record in working with multiple stakeholders and managing their expectations;
- A demonstrated interest in, or understanding of, business ethics and Codes of Ethics;
- Fluent in English and preferably one other European language;
- Based in Europe;
- Strong interpersonal communication skills and willingness to work as part of a team;

- Availability to participate on average to once per week call and attend one-day meetings mainly in Brussels (+/- 1 month).
